PRIVACY POLICY

The Chelsea Academy Foundation (the "Foundation") is a charity registered in England and Wales with charity number 1120784. The Foundation takes the privacy of everyone we interact with very seriously, and we are committed to protecting your personal data. We will not sell your personal data for any reason and will only ever share it with third parties to facilitate our communications with you and administrative purposes that adhere to this privacy policy. This privacy policy relates to information which is obtained by the Foundation and for which the Foundation is the Data Controller. That is to say, data for which the Foundation sets the purpose of the use as well as how this data will be used.

WHAT INFORMATION DO WE COLLECT?

We may collect, store and use the following kinds of personal data:

- 1. Information about your visits to and use of this webpage, webpage and our social media pages;
- Information passed to us by third party, such as fundraising or alumni, websites when you sign up to Foundation-sponsored events. These independent third parties will pass your data to the Foundation where you have indicated that you wish to support the Foundation and have given your consent or it is a necessary part of completing a contract with you;
- 3. Information that you provide to us for the purpose of subscribing to our newsletters and/or email notifications;
- 4. Information received at events for the purpose of supporting the Foundation;
- 5. Information received via correspondence such as email, phone calls, letters or other messaging for the purposes of supporting the Foundation:
- 6. Information received when you make a donation in person, taking part in a fundraising event or other Foundation-sponsored event; or
- 7. Information that is publicly available if we consider that you may be interested in giving major gifts to the Foundation.

We only collect personal data relevant to the type of transactions or interaction you have with the Foundation. Whatever your interaction with us, this information will be minimal and linked to the purpose for which we need it. Typically, we collect the following information:

- Name, address, telephone and/or mobile number, email addresses
- Contact preferences (how we should contact you in the future)
- Credit card and/or Bank account details to facilitate a donation
- Gift Aid status
- Career and professional details to facilitate volunteering, speaking opportunities, work experiences, internships or other opportunities for the purposes of supporting the Foundation
- Records of your correspondence and engagement with us

- Images, photographs or videos if you take part in an event with us, provided that you have given your consent
- Survey responses
- Employer details and National Insurance number if you are a payroll donor
- Details of your relationship to other supporters where appropriate
- Publicly available information such as views and positions you have expressed

This information may be collected via:

- Any paper forms you complete
- Telephone conversations or face-to-face interviews
- Digital forms completed via our webpage or third-party webpages such as Mailchimp, Chelsea Academy, Chelsea Academy alumni and our donation services
- Publicly available sources
- Communication via social media

PURPOSES FOR USING YOUR PERSONAL DATA

Personal data submitted to this webpage will be used for the purposes specified in this privacy policy or in relevant parts of the webpage. In addition to the uses identified elsewhere in this privacy policy, we may use your personal information to:

- 1. Process donations and Gift Aid administration on our database;
- Send our supporters marketing information about our projects, fundraising activities or events and appeals where we have their consent or are otherwise allowed to;
- 3. Recruit trustees and volunteers:
- 4. Record communications to help know when you have supported or contacted the Foundation;
- 5. Verify that communication preferences are current;
- 6. Comply with legal requirements such as DBS checks where applicable;
- 7. For the Foundation's legitimate business interests or activities as a charity;
- 8. Improve your browsing experience; or
- 9. Provide other organisations with statistical information about our users but this information will not be used to identify any individual user.

We may need to let third parties who provide services to the Foundation access your data. These parties support the Foundation with sending emails, complying with legal requirements, processing credit card or bank transfer payments. These "data processors" will only act under our instruction and are subject to pre-contract scrutiny and contractual obligations containing strict data protection clauses. We will only provide these third parties with the relevant information they need to deliver the specific service and we will take all reasonable care to ensure your data is kept secure and treated with respect and integrity.

LEGAL BASES ON WHICH WE RELY

We rely on the following legal bases in our marketing activities:

- Consent: wherever possible, we will ask for your consent to send you marketing information;
- Legitimate Interest: in specific situations, we process your data to pursue our legitimate interests in ways which might reasonably be expected and which do not materially impact your rights, freedom or interests;
- Legal Compliance: if the law requires us, we may need to collect and process your data; and
- Public Interest: in limited situations, we may use data in the public interest.

INFORMATION ABOUT WEBPAGE VISITS

The Foundation, along with Chelsea Academy, may collect information about your computer and your visits to this webpage such as your IP address, geographical location, browser type, referral source, length of visit and number of page views. We may use this information in the administration of this webpage, to improve the webpage's usability, and for marketing purposes. We will take reasonable precautions to prevent the loss, misuse or alteration of your personal information. We ensure that there are appropriate technical controls in place to protect your personal details. Of course, data transmission over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

HOW LONG WILL WE KEEP YOUR PERSONAL INFORMATION

If you request that we stop sending you marketing materials we will keep a record of your contact details and appropriate information to enable us to comply with your request not to be contacted by us.
